## **BETTING, GAMING AND LOTTERIES**

The Betting, Gaming and Lotteries Act 1963 (Variation of Fees) (Scotland) (No.2) Order 1991

Made - - - - 31st October 1991
Laid before Parliament 11th November 1991
Coming into force - - 2nd December 1991

The Secretary of State, in exercise of the powers conferred on him by paragraph 20(1A) of Schedule 1 to the Betting, Gaming and Lotteries Act 1963(1) and of all other powers enabling him in that behalf, hereby makes the following Order:

### 1. -

- (1) This Order may be cited as the Betting, Gaming and Lotteries Act 1963 (Variation of Fees) (Scotland) (No.2) Order 1991 and shall come into force on 2nd December 1991.
  - (2) This Order shall extend to Scotland only.
- 2. Paragraph 20(1) (fees for grant or renewal of bookmakers' permits, betting agency permits and betting office licences) of Schedule 1 to the Betting, Gaming and Lotteries Act 1963 shall be amended by the substitution, for paragraphs (a) to (e), of the following paragraphs:—
  - "(a) in the case of the grant of a bookmaker's permit, £133;
  - (b) in the case of the grant of a betting agency permit, £133(2);
  - (c) in the case of the grant of a betting office licence, £106(3);
  - (d) in the case of the renewal of a bookmaker's permit or betting agency permit, £16(4); and
  - (e) in the case of the renewal of a betting office licence, £20(5);".
- **3.** The Betting, Gaming and Lotteries Act 1963 (Variation of Fees) (Scotland) Order 1987(6) is hereby revoked.

### **EXPLANATORY NOTE**

(This note is not part of the Order)

This Order, which extends to Scotland only, increases certain fees payable to the appropriate authority under paragraph 20(1) of Schedule 1 to the Betting, Gaming and Lotteries Act 1963. The fees for the grant of a bookmaker's permit and for the grant of a betting agency permit are increased from £100 to £133. The fee for the grant of a betting office licence is increased from £80 to £106. The fee for renewal of a bookmaker's permit or betting agency permit is increased from £12 to £16. The fee for renewal of a betting office licence is increased from £15 to £20.
