The Legal Aid in Criminal and Care Proceedings (General) (Amendment) Regulations 1991

Made - - - - 11th March 1991
Laid before Parliament 18th March 1991
Coming into force - - 8th April 1991

The Lord Chancellor, in exercise of the powers conferred on him by sections 21(5), 23, 34 and 43 of the Legal Aid Act 1988(1), and with the consent of the Treasury, hereby makes the following Regulations:—

- 1. These Regulations may be cited as the Legal Aid in Criminal and Care Proceedings (General) (Amendment) Regulations 1991 and shall come into force on 8th April 1991.
- **2.** In these Regulations a regulation or Schedule referred to by number means a regulation or Schedule so numbered in the Legal Aid in Criminal and Care Proceedings (General) Regulations 1989(2).
 - **3.**—(1) In regulation 40(2) after "11" there shall be inserted ",11A".
 - (2) In Schedule 2 Part 2
 - (a) For Form 11 there shall be substituted the following new form:-
