The Secretary of State for Transport makes this Instrument in exercise of powers conferred by Section 106(3) of the Highways Act 1980(1), and now vested in him(2), and of all other enabling powers:—

- **1.** The County Council of Norfolk (A1151 Wroxham/Hoveton Bypass, River Bure Bridge) Scheme 1988 is hereby confirmed without modifications.
- **2.** The said Scheme as confirmed (hereinafter referred to as "the Scheme") is set out in the Schedule hereto and copies of the Scheme with its accompanying plan are deposited at the offices of the Department of Transport, Romney House, 43 Marsham Street, London SW1P 3PY and at the offices of the Norfolk County Council, County Hall, Martineau Lane, Norwich NR1 2DH.
- **3.** The Scheme will come into force on the date on which notice that it has been confirmed is first published in accordance with paragraph 1 of Schedule 2 of the Highways Act 1980.
- **4.** This Instrument may be cited as the County Council of Norfolk (A1151 Wroxham/Hoveton Bypass, River Bure Bridge) Scheme 1988 Confirmation Instrument 1992.


