The Registration of Births and Deaths (Welsh Language) (Amendment) Regulations 1992

Amendment of Schedule 3

4. Schedule 3 (prescribed words)—

- (a) for the entry “Reg. 10(b)(ii)” in column 1 there shall be substituted the entry “Reg. 10(1)(b)(ii)”,
- (b) for the entry “Reg. 10(b)(iii)” in column 1 there shall be substituted the entry “Reg. 10(1)(b)(iii)”,
- (c) for the entry “Reg. 10(b)(iv)” in column 1 there shall be substituted the entry “Reg. 10(1)(b)(iv)”,
- (d) after that entry relating to regulation 10(1)(b)(iv) there shall be inserted the following entries in columns (1), (2) and (3) respectively—
