The Secretary of State for Health, in exercise of the powers conferred by section 92(1) of the National Health Service Act 1977(1) and of all other powers enabling him in that behalf, having regard to the change in the arrangements for the administration of hospitals and other establishments and facilities formerly managed by Liverpool Health Authority resulting from the establishment of the Royal Liverpool Children's Hospital and Community Services National Health Service Trust(2), having consulted that Health Authority and that Trust in accordance with section 92(3) of that Act, hereby makes the following Order:

**Citation, commencement and interpretation**

1.—(1) This Order may be cited as the Royal Liverpool Children's Hospital and Community Services National Health Service Trust (Transfer of Trust Property) Order 1992 and shall come into operation on 1st April 1992.

(2) In this Order—

“the Authority” means Liverpool Health Authority;

“the Trust” means the Royal Liverpool Children's Hospital and Community Services National Health Service Trust;

“the trust property” means the items specified in a schedule of trust property prepared by and agreed upon by the Authority and the Trust before the date on which this Order is made, which schedule has been signed on behalf of both the Authority and the Trust.
