# HOUSING, ENGLAND AND WALES

The Housing Renovation etc. Grants (Prescribed Forms and Particulars) (Amendment) Regulations 1992

Made - - - - 9th March 1992
Laid before Parliament 11th March 1992
Coming into force - - 6th April 1992

The Secretary of State for the Environment, as respects England, and the Secretary of State for Wales, as respects Wales, in exercise of the powers conferred on them by sections 102(2) and (4), 137(2) and 138(1)(1) of the Local Government and Housing Act 1989(2), and of all other powers enabling them in that behalf, hereby make the following Regulations:—

#### Citation and commencement

1. These Regulations may be cited as the Housing Renovation etc. Grants (Prescribed Forms and Particulars) (Amendment) Regulations 1992 and shall come into force on 6th April 1992.

### **Amendment of Regulations**

- **2.**—(1) The forms in the Schedule to the Housing Renovation etc. Grants (Prescribed Forms and Particulars) Regulations 1990(3) are amended in accordance with this regulation.
- (2) In question 3.13 on Forms 1 and 2 omit the reference to "Note 30" against "mobility allowance".

#### **EXPLANATORY NOTE**

(This note is not part of the Regulations)

These Regulations amend the forms in the Schedule to the Housing Renovation etc. Grants (Prescribed Forms and Particulars) Regulations 1990. The amendments are consequential upon amendments made by the Housing Renovation etc. Grants (Reduction of Grant) (Amendment) Regulations 1992 (S.I.1992/705) to the Housing Renovation etc. Grants (Reduction of Grant) Regulations 1990 (S.I. 1990/1189) in relation to disability living allowance and disability working allowance.

The Regulations provide that the amendments do not apply in respect of any application for a grant made before the date on which these Regulations come into force.
