**The High Court of Justiciary Fees Amendment Order 1993**

3. The High Court of Justiciary Fees Amendment Order 1992((3)) is hereby revoked.

## EXPLANATORY NOTE

*(This note is not part of the Order)*

This Order increases from 1st April 1993 some of the fees payable to the Principal Clerk of Session and Justiciary or any officer acting for him in relation to proceedings in the High Court of Justiciary.
