# NATIONAL HEALTH SERVICE, ENGLAND AND WALES

The Ashford Hospital National Health Service Trust (Transfer of Trust Property) Order 1994

Made - - - - 12th April 1994
Laid before Parliament 19th April 1994
Coming into force - - 10th May 1994

The Secretary of State for Health, in exercise of the powers conferred on her by section 92(1) of the National Health Service Act 1977((1)) and of all other powers enabling her in that behalf, having regard to the change in the arrangements for the administration of hospitals and other establishments and facilities formerly managed by the Hounslow and Spelthorne Health Authority resulting from the establishment of the Ashford Hospitals National Health Service Trust((2)) (now called the Ashford Hospital National Health Service Trust((3))), having consulted Ealing, Hammersmith and Hounslow Health Authority((4)), and that Trust in accordance with section 92(3) of that Act, hereby makes the following Order:

#### Citation, commencement and interpretation

- 1.—(1) This Order may be cited as the Ashford Hospital National Health Service Trust (Transfer of Trust Property) Order 1994 and shall come into force on 10th May 1994.
  - (2) In this Order-

"the Authority" means the Ealing, Hammersmith and Hounslow Health Authority;

"the Trust" means the Ashford Hospital National Health Service Trust;

"the trust property" means the items specified in a schedule of trust property prepared by and agreed upon by the Authority and the Trust on 12th January 1994, which schedule has been signed on behalf of both the Authority and the Trust.
