**The Royal Cornwall Hospitals National Health  
Service Trust (Transfer of Trust Property) Order 1994**

The Secretary of State for Health, in exercise of the powers conferred on her by section 92(1) of the National Health Service Act 1977(1) and of all other powers enabling her in that behalf, having regard to the change in the arrangements for the administration of hospitals and other establishments and facilities formerly managed by the Cornwall and Isles of Scilly Health Authority resulting from the establishment of the Royal Cornwall Hospital and West Cornwall Hospital NHS Trust, now known as the Royal Cornwall Hospitals National Health Service Trust(2), having consulted that Health Authority and that Trust in accordance with section 92(3) of that Act, hereby makes the following Order:

**Citation, commencement and interpretation**

1.—(1) This Order may be cited as the Royal Cornwall Hospitals National Health Service Trust (Transfer of Trust Property) Order 1994 and shall come into force on 9th June 1994.

(2) In this Order—

“the Authority” means the Cornwall and Isles of Scilly Health Authority;

“the Trust” means the Royal Cornwall Hospitals National Health Service Trust;

“the trust property” means the items specified in a schedule of trust property prepared by and agreed upon by the Authority and the Trust on 15th July 1993, which schedule has been signed on behalf of both the Authority and the Trust.
