# LANDLORD AND TENANT, ENGLAND AND WALES

The Rent Act 1977 (Forms, etc.) (Welsh Forms and Particulars) (Amendment) Regulations 1994

Coming into force - - 6th April 1994

The Secretary of State for Wales, in exercise of the powers conferred on him by sections 66(2), 67(2), 67A(5), 73(3) and 74(1) of the Rent Act 1977(1) as extended by section 26(3) of the Welsh Language Act 1993(2) and of all other powers enabling him in that behalf hereby makes the following Regulations:

#### Citation and commencement

**1.** These Regulations may be cited as the Rent Act 1977 (Forms, etc.) (Welsh Forms and Particulars) (Amendment) Regulations 1994 and shall come into force on 6th April 1994.

#### Amendment

**2.** The Rent Act 1977 (Forms, etc.) (Welsh Forms and Particulars) Regulations 1993(**3**) are amended as follows:–

  - (i) in question 4 of "Ffurflen Rhif 5", "Ffurflen Rhif 6", "Ffurflen Rhif 7", "Ffurflen Rhif 9A" and "Ffurflen Rhif 10", add after the words "ar ba lawr" the words "neu loriau";
  - (ii) in question 1 of "Ffurflen Rhif 10" for the words "yr ydych am gofrestru rhent ar ei gyfer" there are substituted the words "y mae'r rhent wedi ei gofrestru ar ei gyfer";
