The European Communities (Definition of Treaties) (Europe Agreement establishing an Association between the European Communities and their Member States and the Slovak Republic) Order 1994

> Made - - - 15th March 1994 Coming into force in accordance with Article 1

At the Court at Buckingham Palace, the 15th day of March 1994

Present,

The Queen's Most Excellent Majesty in Council

Whereas a draft of this Order has been laid before Parliament in accordance with section 1 of the European Communities Act 1972(1) and has been approved by a resolution of each House of Parliament:

Now, therefore, Her Majesty, in exercise of the powers conferred on Her by section 1(3) of the European Communities Act 1972 or otherwise in Her Majesty vested, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

1. This Order may be cited as the European Communities (Definition of Treaties) (Europe Agreement establishing an Association between the European Communities and their Member States and the Slovak Republic) Order 1994. It shall come into force, in respect of the treaty specified in the Schedule to this Order, on the date on which the treaty enters into force for the United Kingdom. This date will be notified in the London, Edinburgh and Belfast Gazettes.

### **EXPLANATORY NOTE**

(This note is not part of the Order)

This Order declares the Europe Agreement establishing an Association between the European Communities and their Member States, of the one part, and the Slovak Republic of the other part, signed on 4 October 1993, to be a Community Treaty as defined in section 1(2) of the European Communities Act 1972. The Agreement establishes the Association with the aims of providing an appropriate framework for political dialogue, for promoting the expansion of trade and economic relations, providing a basis for the Community's financial and technical assistance to the Slovak Republic, promoting cultural co-operation and providing an appropriate framework for the Slovak Republic's gradual integration into the Community. The principal effect of declaring this Agreement to be a Community Treaty as so defined is to bring into play, in relation to it, the provisions of section 2 of the European Communities Act 1972 which provides for the implementation of treaties so specified.
