The Section 19 Minibus (Designated Bodies) (Amendment) Order 1995

The Secretary of State for Transport, in exercise of the powers conferred by section 19(7) of the Transport Act 1985(1) and of all other powers enabling him in that behalf, hereby makes the following Order:—

Citation and commencement

1. This Order may be cited as the Section 19 Minibus (Designated Bodies) (Amendment) Order 1995 and shall come into force on 17th July 1995.

Interpretation

2. In this Order—

“the principal order” means the Section 19 Minibus (Designated Bodies) Order 1987(2); and
“the Schedule” means the Schedule to the principal order.

Amendment of the principal order

3.—(1) The principal order shall be amended in accordance with articles 4, 5, 6 and 7 below.

Bodies ceasing to be designated

4. Items 32, 33, 61, 70 and 71 of the Schedule shall be omitted.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Section 19 Minibus (Designated Bodies) Order 1987. Five bodies cease to be designated under section 19 of the Transport Act 1985, six bodies are newly designated, the current names and addresses of three bodies are substituted for those given in the 1987 Order and the current addresses of twelve designated bodies are so substituted.
