The County Council of Norfolk (Reconstruction of Welney Suspension Bridge) Scheme 1994 Confirmation Instrument 1995

The Secretary of State for Transport makes this Instrument in exercise of powers conferred by section 106(3) of the Highways Act 1980(1), and now vested in him(2), and of all other powers enabling him in that behalf:—

- 1. This Instrument may be cited as The County Council of Norfolk (Reconstruction of Welney Suspension Bridge) Scheme 1994 Confirmation Instrument 1995 and shall come into force on the date on which notice that it has been confirmed is first published in accordance with paragraph 1 of Schedule 2 to the Highways Act 1980.
- **2.** The County Council of Norfolk (Reconstruction of Welney Suspension Bridge) Scheme 1994 ("the Scheme") is hereby confirmed with modifications.





# POINTS OF COMMENCEMENT AND TERMINATION OF THE RIVER SPAN

FROM A POINT ON THE EAST BANK OF THE NEW BEDFORD RIVER OR HUNDRED FOOT DRAIN APPROXIMATELY 82 METRES WEST OF THE WEST CORNER OF THE OLD CROWN HOUSE TO A POINT ON THE EAST BANK OF THE RIVER APPROXIMATELY 53 METRES NORTH OF THE WEST CORNER OF THE BUILDING MARKED BANK FARM ON PLAN B.

### NAVIGATION SPAN

NOT LESS THAN 30.0 METRES MEASURED ALONG THE BRIDGE.

### HEADROOM AND WATERWAY

THE NAVIGATION WATERWAY HAS A WIDTH OF NOT LESS THAN 15.0 METRES. FOR THIS WIDTH THE SOFFIT LEVEL IS 6.34 METRES AOD ON THE WESTERN SIDE, AND 6.24 METRES AOD ON THE EASTERN SIDE.
