**The South and East Wales Ambulance National Health
Service Trust (Transfer of Trust Property) (No.3) Order 1995**

Laid before Parliament *28th September 1995*
Coming into force - - *23rd October 1995*

The Secretary of State for Wales, in exercise of the powers conferred on him by section 92(1) of the National Health Service Act 1977(1) and of all other powers enabling him in that behalf, having regard to the change in the arrangements for the administration of hospitals and other establishments and facilities formerly managed by South Glamorgan Health Authority resulting from the establishment of the South and East Wales Ambulance National Health Service Trust(2), having consulted that Health Authority and that Trust in accordance with section 92(3) of that Act, hereby makes the following Order:—

Citation, commencement and interpretation

1.—(1) This Order may be cited as the South and East Wales Ambulance National Health Service Trust (Transfer of Trust Property) (No.3) Order 1995(3) and shall come into force on 23rd October 1995.

(2) In this Order—

“the Authority” means South Glamorgan Health Authority;

“the Trust” means the South and East Wales Ambulance National Health Service Trust;

“the trust property” means the items specified in a schedule of trust property prepared by and agreed upon by the Authority and the Trust on 15th August 1995, which schedule has been signed on behalf of both the Authority and the Trust.
