**The National Blood Authority (Transfer  
of Trust Property) (No. 2) Order 1995**

The Secretary of State for Health, in exercise of the powers conferred on him by section 92(1) of the National Health Service Act 1977(1) and of all other powers enabling him in that behalf, having regard to the change in the arrangements for the administration of establishments and facilities formerly managed by the Yorkshire Regional Health Authority resulting from the establishment of the National Blood Authority(2), having consulted the Northern and Yorkshire Regional Health Authority(3) and the National Blood Authority in accordance with section 92(3) of that Act, hereby makes the following Order:

**Citation, commencement and interpretation**

1.—(1) This Order may be cited as the National Blood Authority (Transfer of Trust Property) (No. 2) Order 1995 and shall come into force on 22nd December 1995.

(2) In this Order—

“the first Authority” means the Northern and Yorkshire Regional Health Authority;

“the second Authority” means the National Blood Authority;

“the trust property” means the items specified in a schedule of trust property prepared by and agreed upon by the first Authority and the second Authority on 21st February 1995, which schedule has been signed on behalf of both the first Authority and the second Authority.
