**The Richmond, Twickenham and Roehampton
Healthcare National Health Service Trust
(Transfer of Trust Property) Order 1995**

Made - - - - *1st February 1995*
Laid before Parliament *22nd February 1995*
Coming into force - - *15th March 1995*

The Secretary of State for Health, in exercise of the powers conferred on her by section 92(1) of the National Health Service Act 1977(1) and of all other powers enabling her in that behalf, having regard to the change in the arrangements for the administration of hospitals and other establishments and facilities resulting from the establishment of the Richmond, Twickenham and Roehampton Healthcare National Health Service Trust(2), having consulted the Special Trustees for Westminster and Roehampton Hospitals and that Trust in accordance with section 92(3) of that Act, hereby makes the following Order:

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Richmond, Twickenham and Roehampton Healthcare National Health Service Trust (Transfer of Trust Property) Order 1995 and shall come into force on 15th March 1995.

(2) In this Order—

“the Special Trustees” means the Special Trustees for Westminster and Roehampton Hospitals;

“the Trust” means the Richmond, Twickenham and Roehampton Healthcare National Health Service Trust;

“the trust property” means the items specified in a schedule of trust property prepared by and agreed upon by the Special Trustees and the Trust on 29th September 1994, which schedule has been signed on behalf of both the Special Trustees and the Trust.
