**The United Leeds Teaching Hospitals National  
Health Service Trust Dissolution Order 1995**

*Made* - - - - *17th March 1995*

*Coming into force* - - *1st April 1995*

The Secretary of State for Health, in exercise of powers conferred on her by section 126(3) of the National Health Service Act 1977<sup>(1)</sup> and section 5(1) of, and paragraph 29(1) of Schedule 2 to, the National Health Service and Community Care Act 1990<sup>(2)</sup> and of all other powers enabling her in that behalf, considering it appropriate in the interests of the health service to make this Order<sup>(3)</sup>, and after completion of the consultation prescribed under paragraph 29(3) of Schedule 2 to the latter Act<sup>(4)</sup>, hereby makes the following Order:

**Citation and commencement**

1. This Order may be cited as the United Leeds Teaching Hospitals National Health Service Trust Dissolution Order 1995 and shall come into force on 1st April 1995.

**Dissolution of NHS trust**

2. The United Leeds Teaching Hospitals National Health Service Trust established by the Leeds General Infirmary and Associated Hospitals National Health Service Trust (Establishment) Order 1990<sup>(5)</sup> is hereby dissolved, and accordingly that Order and the Leeds General Infirmary and Associated Hospitals National Health Service Trust (Change of Name) Order 1991<sup>(6)</sup> are hereby revoked.
