The Road Traffic (Special Parking Area) (Royal Borough of Kingston upon Thames) (Amendment) Order 1996

Whereas the council of the royal borough of Kingston upon Thames has applied to the Secretary of State for Transport for an order to be made under section 76 of the Road Traffic Act 1991⁽¹⁾ and the Secretary of State has consulted the Commissioner of Police of the Metropolis in accordance with section 76(2) of that Act:

NOW, the Secretary of State for Transport, in exercise of the powers conferred by section 76(1) and section 77(6) of Road Traffic Act 1991 and of all other powers enabling him in that behalf, hereby makes the following Order:—

Citation and commencement

1. This Order may be cited as the Road Traffic (Special Parking Area) (Royal Borough of Kingston upon Thames) (Amendment) Order 1996 and shall come into force on 20th May 1996.

Amendment of the Road Traffic (Special Parking Area) (Royal Borough of Kingston upon Thames) Order 1994

2.—(1) The Schedule to the Road Traffic (Special Parking Area) (Royal Borough of Kingston upon Thames) Order 1994⁽²⁾ shall be amended as follows.

(2) After paragraph 10 there shall be inserted the following paragraph—

“**10A.** Highfield Road between its junction with Tolworth Rise North service road and a point 21m north west of the south eastern boundary of 153 Tolworth Rise North.”

(3) After paragraph 25 there shall be inserted the following paragraph—
