**The Social Security (Persons From Abroad)

The Secretary of State for Social Security, in exercise of powers conferred upon him by sections 64(1), 68(4)(c)(i), 70(4), 71(6), 123(1), 124(1), 128(1), 129(1), 130(1) and (2), 131(1) and (3), 135, 137(1) and (2)(a) and (i) and 175(1) and (3) to (5) of the Social Security Contributions and Benefits Act 1992^{M1} and section 5(1)(r) of the Social Security Administration Act 1992^{M2} and of all other powers enabling him in that behalf, and so far as they relate to housing benefit and council tax benefit after consultation with organisations appearing to him to be representative of the authorities concerned^{M3}, and after reference to the Social Security Advisory Committee^{M4}, hereby makes the following Regulations:—
