(4) "Το πτυχίο της Ανωτάτης ΝοσηλευτιΧής της Σχολής Επαγγελμάτων Υγείας, ΤμήμαΝοσηλευτιΧής του Πανεπτιστημίου Αθηνών"(degree in nursing from the faculty of health sciences, nursing section, University of Athens).

Iceland

Ireland

9. The certificate of "Registered General Nurse" issued by "An Bord Altranais" (the Nursing Board).
