## The Railways (Amendment) Regulations 1998

The Secretary of State, being a Minister designated(1) for the purpose of section 2(2) of the European Communities Act 1972(2) in relation to measures relating to railways and railway transport, in exercise of the powers conferred by that section hereby makes the following Regulations:—

1. These Regulations may be cited as the Railways (Amendment) Regulations 1998 and shall come into force on 27th June 1998.
