**The Teaching and Higher Education Act
1998 (Commencement No. 3) Order 1998**

Made - - - - 3rd September 1998

In exercise of the powers conferred by section 46(4) of the Teaching and Higher Education Act 1998(1), the Secretary of State for Education and Employment hereby makes the following Order:

Citation and interpretation

1.—(1) This Order may be cited as the Teaching and Higher Education Act 1998 (Commencement No. 3) Order 1998.

(2) In this Order—

“the 1988 Act” means the Education Reform Act 1988(2); and

“the 1998 Act” means the Teaching and Higher Education Act 1998.

Provisions coming into force

2. The following provisions of the 1998 Act shall come into force on 1st October 1998:
- section 1(1), to the extent that it defines the “the Council” but not so as to establish the General Teaching Council for England as a body;

 - paragraph 6;
 - paragraph 7;
 - paragraph 8;
 - paragraph 9; and
 - paragraph 15;
 - in Schedule 4, the repeal of–
 - in section 218(1)(c) of the 1988 Act, the words “schools and”; and
 - in section 232(6) of the 1988 Act, the words “other than section 218(1)(b) or (c), (5) or (6)”.
- 3.** Section 19(9) and (10)(a) of the 1998 Act shall come into force on 1st April 1999.
