LOCAL GOVERNMENT, SCOTLAND

The East Renfrewshire (Electoral Arrangements) Order 1998

Made - - - - *4th December 1998*

Coming into force - - *1st January 1999*

Whereas under section 17(1) of the Local Government (Scotland) Act 1973(1), as read with Schedule 5 to that Act(2), the Local Government Boundary Commission for Scotland on 3rd September 1998 submitted to the Secretary of State a report on a review together with its proposals for the future electoral arrangements for the area of East Renfrewshire Council;

Now, therefore, in exercise of the powers conferred on him by sections 17(2) and 233(3) of, and Schedule 5 to, the said Act and of all other powers enabling him in that behalf, the Secretary of State hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the East Renfrewshire (Electoral Arrangements) Order 1998 and shall come into force on 1st January 1999.

Interpretation

2. In the Schedule to this Order—

(a) a reference to—

(i) an electoral ward is a reference to that electoral ward as constituted in this Order; and

(ii) a road, footpath, railway line, river, burn or canal shall, where the context so admits, be construed as a reference to the centre line of the feature concerned; and

(b) the following abbreviations are used:—

“EW” for electoral ward;

“NG Ref” for National Grid Reference as published on Ordnance Survey Maps.

Electoral arrangements

3. The area of East Renfrewshire Council shall be divided into 20 wards, having the names, contents and boundaries set forth in the Schedule to this Order.

Ward 19 Mearns

Commencing at NG Ref NS 5347 5576 where the southern boundary of EW 7 meets the southern boundary of EW 12; then generally southeastward and northeastward along the said EW boundary to and generally southeastward and northeastward along the southern boundary of EW 15 to the southern boundary of EW 16; then generally southeastward along the said EW boundary to and generally southwestward along western boundary of EW 17 to where Humble Road crosses the Earn Water at Humble Bridge, NG Ref NS 5493 5437; then generally southwestward along the said water to the southern boundary of East Renfrewshire Council at NG Ref NS 5033 5030; then generally southwestward and northwestward along the said Council boundary to and generally northeastward along the southern boundary of EW 7 to the point of commencement.

Ward 20 Eaglesham

Commencing at NG Ref NS 5493 5437 where the eastern boundary of EW 19 meets the southern boundary of EW 17; then generally southeastward and northeastward along the said EW boundary to and generally southeastward, southward, southwestward and northwestward along the eastern and southern boundaries of East Renfrewshire Council to and generally northeastward along the eastern boundary of EW 19 to the point of commencement.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order gives effect (with minor modifications of a drafting nature) to proposals made by the Local Government Boundary Commission for Scotland for the future electoral arrangements for the area of East Renfrewshire Council. The proposals follow on the review of the whole of Scotland undertaken by the Commission in terms of Schedule 5 to the Local Government (Scotland) Act 1973. The area of East Renfrewshire Council is divided into 20 electoral wards as described in the Schedule to the Order. In terms of paragraph 1 of Schedule 2 to the Local Government etc. (Scotland) Act 1994, the wards apply with effect from the ordinary election of councillors due to take place in May 1999.
