**The Special Trustees for Westminster and Roehampton
Hospitals (Transfer of Trust Property) Order 1998**

The Secretary of State for Health, in exercise of the powers conferred on him by section 92(1) of the National Health Service Act 1977(1) and of all other powers enabling him in that behalf, having regard to the change in the arrangements for the administration of hospitals and other establishments and facilities resulting from the establishment of the Chelsea and Westminster Healthcare National Health Service Trust(2), having consulted that Trust and the Special Trustees for Westminster and Roehampton Hospitals in accordance with section 92(3) of that Act, hereby makes the following Order:

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Special Trustees for Westminster and Roehampton Hospitals (Transfer of Trust Property) Order 1998 and shall come into force on 27th March 1998.

(2) In this Order—

“the Special Trustees” means the Special Trustees for Westminster and Roehampton Hospitals;

“the Trust” means the Chelsea and Westminster Healthcare National Health Service Trust;

“the trust property” means the items specified in a schedule of trust property prepared by, agreed upon by and signed on behalf of the Special Trustees and the Trust on 22nd December 1997.
