The Lewisham and Guy's Mental Health National Health Service Trust (Transfers of Trust Property) Order 1998

The Secretary of State for Health, in exercise of the powers conferred on him by section 92(1) of the National Health Service Act 1977(1) and of all other powers enabling him in that behalf, having regard to the change in the arrangements for the administration of hospitals and other establishments and facilities resulting from the establishment of the Lewisham and Guy's Mental Health National Health Service Trust(2), having consulted the bodies specified in the Schedule to this Order and that Trust in accordance with section 92(3) of that Act, hereby makes the following Order:

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Lewisham and Guy's Mental Health National Health Service Trust (Transfers of Trust Property) Order 1998 and shall come into force on 23rd April 1998.

(2) In this Order—

"the Schedule" means the Schedule to this Order;

"the Trust" means the Lewisham and Guy's Mental Health National Health Service Trust;

"the trust property" means, in the case of each body specified in the Schedule, the items specified in a schedule of trust property prepared by, agreed upon by and signed on behalf of that body and the Trust on 28th May 1997.

Transfer of trust property

2. On 23rd April 1998, in the case of each body specified in the Schedule, the trust property shall be transferred from that body to the Trust.
