# 1999 No. 1869

## The Merchant Shipping (Counting and Registration of Persons on Board Passenger Ships) Regulations 1999

### **[<sup>F1</sup>Ships which are on voyages from outside of the United Kingdom and are not United Kingdom ships]**

7. In respect of any passenger ship which is not <sup>F2</sup>...[<sup>F3</sup> a United Kingdom passenger ship,] on any voyage from any landing point outside the [<sup>F4</sup>territory [<sup>F5</sup>of] the United Kingdom] to the United Kingdom [<sup>F6</sup>the owner shall—

- (a) communicate information as to the total number of persons on board the ship in accordance with regulation 5(4); and
- (b) report the information specified in regulation 6(3) in accordance with regulation 6(2)(b)].
