**2A.—(1) (2)** The weekly amount for the purposes of regulations 17(1)(bb) and 18(1)(cc) (residential allowance) in respect of a person who satisfies the conditions specified in subparagraph (2) shall be—

- (a) except in a case to which head (b) applies, £59.40; and
- (b) where the home in which the person resides is situated within the area described in Schedule 3C (the Greater London area), £66.10.”
