The Lord Chancellor, in exercise of the powers conferred on him by section 4 of the Justices of the Peace Act 1997(**a**), makes the following Order:

Citation and commencement

1. This Order may be cited as the Petty Sessions Areas (Amendment) Order 1999 and shall come into force on 1st January 2000.

Petty sessions areas

- 2. In Part I of the Schedule to the Petty Sessions Areas Order 1999(b)—
 - (a) for the entries in column 1 opposite the entry "BEDFORDSHIRE" in column 2 there shall be substituted—
 - "Bedford and Mid Bedfordshire
 - Luton and South Bedfordshire"(c);
 - (b) for the entries in column 1 opposite the entry "ESSEX" in column 2 there shall be substituted—
 - "Mid-North Essex
 - Mid-South Essex
 - North-East Essex
 - North-West Essex
 - South-East Essex
 - South-West Essex"(d);
 - (c) for the entries in column 1 opposite the entry "KENT" in column 2 there shall be substituted—
 - "Canterbury and St. Augustine
 - Channel
 - Dartford and Gravesham
 - Faversham and Sittingbourne
 - Medway
 - Mid Kent
 - Thanet
 - West Kent"(e);
