**The Afghanistan (United Nations Sanctions)  
(Channel Islands) (Amendment) Order 1999**

*Made* - - - - *14th December 1999*

*Laid before Parliament* *22nd December 1999*

*Coming into force* *23rd December 1999*

At the Court at Buckingham Palace, the 14th day of December 1999

Present,

The Queen's Most Excellent Majesty in Council

Whereas under Article 41 of the Charter of the United Nations the Security Council of the United Nations has, by a resolution adopted on 15th October 1999, called upon Her Majesty's Government in the United Kingdom and all other States to apply certain measures to give effect to a decision of that Council in relation to Afghanistan:

Now, therefore, Her Majesty, in exercise of the powers conferred on Her by section 1 of the United Nations Act 1946(a), is pleased, by and with the advice of her Privy Council, to order, and it is hereby ordered, as follows:—

**1.**—(1) This Order may be cited as the Afghanistan (United Nations Sanctions) (Channel Islands) (Amendment) Order 1999 and shall come into force on 23rd December 1999.

(2) In this Order, “the Order” means the Afghanistan (United Nations Sanctions) (Channel Islands) Order 1999(b).

(3) This Order shall extend to the Channel Islands so as to be law, respectively, in the Bailiwick of Guernsey and in the Bailiwick of Jersey only.

**2.** In article 1(2) of the Order there shall be inserted after the words “which has the effect of” the word “amending”.

**3.** In article 2 of the Order for the definition of “police officer” there shall be substituted the following—

““police officer” in relation to Jersey, has the meaning provided in the Police Force (Jersey) Law 1974;”.

4. In article 3(2) of the Order there shall be inserted after the words “Sanctions Committee” the words “; and particulars of any such designation shall be published by the Secretary of State”.

5. In article 4(1)(a) of the Order there shall be inserted after the words “or a British National (Overseas)” the words “and is ordinarily resident in the Bailiwick of Guernsey or, as the case may be, the Bailiwick of Jersey”.

This Order, made under the United Nations Act 1946, corrects errors in S.I. 1999/3134 which gave effect in the Channel Islands to the imposition of restrictions pursuant to a decision of the Security Council of the United Nations in Resolution No. 1267 of 15th October 1999 on certain actions making available or otherwise transferring funds and financial resources to or for the benefit of the Taliban.
