The Allington, the East Suffolk Local Health Services and the Mid Anglia Community Health National Health Service Trusts (Dissolution) Order 1999

Made	15th March 1999
Coming into force	1st April 1999

The Secretary of State for Health, in exercise of the powers conferred on him by section 126(3) of the National Health Service Act 1977(a) and by section 5(1) of, and paragraph 29(1) of Schedule 2 to, the National Health Service and Community Care Act 1990(b) and of all other powers enabling him in that behalf, considering it appropriate in the interests of the health service to make this Order(c), and after completion of the consultation prescribed under paragraph 29(3) of Schedule 2 to the latter Act(d), hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Allington, the East Suffolk Local Health Services and the Mid Anglia Community Health National Health Service Trusts (Dissolution) Order 1999 and shall come into force on 1st April 1999.

Dissolution of NHS trusts

2.—(1) The Allington National Health Service Trust established by the Allington National Health Service Trust (Establishment) Order 1991(e) shall be dissolved on 1st April 1999, and accordingly that Order revoked on that date.

(2) The East Suffolk Local Health Services National Health Service Trust established by the East Suffolk Local Health Services National Health Service Trust (Establishment) Order 1992(f) shall be dissolved on 1st April 1999, and accordingly that Order revoked on that date.

(3) The Mid Anglia Community Health National Health Service Trust established by the Mid Anglia Community Health National Health Service Trust (Establishment) Order 1992(g) shall be dissolved on 1st April 1999, and accordingly that Order revoked on that date.
