The Social Security (Work-focused Interviews for Lone Parents) and Miscellaneous Amendments Regulations 2000

[^{F1}Requirement for certain lone parents to take part in an interview

2ZA.—(1) This regulation applies to a lone parent if—

- (a) he is entitled to income support and is a person to whom paragraph 1 (lone parents) of Schedule 1B to the Income Support (General) Regulations 1987 applies; [^{F2}and]
- (b) no other paragraph of that Schedule applies to him; ^{F3}...
- ^{F3}(c)

[^{F4}(2) Subject to regulations 4 and 5, a lone parent to whom this regulation applies is required to take part in one or more interviews as a condition of continuing to be entitled to the full amount of benefit which is payable to him apart from these Regulations.]

(3) A lone parent who—

- (a) is required to take part in [^{F5}a relevant interview] under this regulation, or
- (b) has had a requirement to take part in [^{F5} a relevant interview] under this regulation ^{F6} ... deferred,

is not required to take part in an interview under regulation 2 unless this regulation ceases to apply to him.]
