# The East Gloucestershire National Health Service Trust (Establishment) Amendment Order 2000

**2.** In sub-paragraph (b) of article 3(2) of the East Gloucestershire National Health Service Trust (Establishment) Order 1990(d) (nature and functions of the trust), for the words "Burlington House, Lypiatt Road, Cheltenham GL50 2QN" substitute the words "Trust HQ, Number 1 College Lawn, Cheltenham GL53 7AG".
