The National Health Service (General Medical Services) Amendment (No. 2) Regulations

Made	7th March 2000
Laid before Parliament	8th March 2000
Coming into force	1st April 2000

The Secretary of State for Health, in exercise of the powers conferred upon him by sections 29 and 126(4) of the National Health Service Act $1977(\mathbf{a})$, and of all other powers enabling him in that behalf, hereby makes the following Regulations:

Citation, commencement and interpretation

1.—(1) These Regulations may be cited as the National Health Service (General Medical Services) Amendment (No. 2) Regulations 2000 and shall come into force on 1st April 2000.

(2) In these Regulations, the "1992 Regulations" means the National Health Service (General Medical Services) Regulations 1992(b).

(3) These Regulations extend to England only.

Amendment of the 1992 Regulations

2.—(1) In regulation 34(2) of the 1992 Regulations (payments), for sub-paragraph (e) shall be substituted—

"(e) allowances for study leave;".

As regards Wales, the functions of the Secretary of State under sections 29 and 126(4) of the 1977 Act are transferred to the National Assembly for Wales under article 2 of, and Schedule 1 to, the National Assembly for Wales (Transfer of Functions) Order 1999, S.I. 1999/672; these Regulations therefore extend only to England.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations further amend the National Health Service (General Medical Services) Regulations 1992 ("the 1992 Regulations"), which regulate the terms on which General Medical Services are provided under the National Health Service Act 1977.

Regulation 34(2) is amended to remove the reference to allowances for training doctors from the matters for which provision shall be made in a determination under paragraph (1) of that regulation. Health Authorities are now to make payments in respect of allowances for training doctors in accordance with the directions to Health Authorities concerning GP Registrars.
