**SOCIAL SECURITY**

**The Social Security Commissioners  
(Procedure) (Amendment) Regulations 2001**

*Made* - - - - 20th March 2001

*Coming into force* - - 2nd July 2001

The Lord Chancellor, in exercise of the powers conferred upon him by paragraphs 8 to 10, 19, 20(1) and (3) and 23(1) and (2) of Schedule 7 to the Child Support, Pensions and Social Security Act 2000<sup>M1</sup>, sections 14 to 16, 28, 79(2), (4) and (6) and 84 of, and Schedules 4 and 5 to, the Social Security Act 1998<sup>M2</sup>, section 4(2) of the Forfeiture Act 1982<sup>M3</sup>, and of all other powers enabling him in that behalf, after consultation with the Scottish Ministers, in accordance with section 79(2)<sup>M4</sup> of the Social Security Act 1998 and paragraph 20(1) of Schedule 7 to the Child Support, Pensions and Social Security Act 2000, and with the Council on Tribunals in accordance with section 8 of the Tribunals and Inquiries Act 1992<sup>M5</sup>, makes the following Regulations, a draft of which has, in accordance with section 80(1) of the Social Security Act 1998, been laid before and approved by resolution of each House of Parliament:

**Citation, commencement and interpretation**

1.—(1) These Regulations may be cited as the Social Security Commissioners (Procedure) (Amendment) Regulations 2001 and shall come into force on 2nd July 2001.

(2) In these Regulations a reference to a regulation by number alone means the regulation so numbered in the Social Security Commissioners (Procedure) Regulations 1999 <sup>M6</sup>.

- (i) any person or organisation other than the applicant, appellant or person making the reference who is one of the principal parties as defined in section 13 of the 1998 Act,
- (ii) any other person taking part in the proceedings in accordance with section 14 of the 1998 Act or as a person affected or as a relevant authority or at the direction or with the leave of the Commissioner,
- (iii) the Secretary of State in any case where he is not otherwise a respondent and has given notice to the Commissioner of his wish to be joined as a party to the proceedings.”;]

## EXPLANATORY NOTE

*(This note is not part of the Regulations)*

These Regulations amend the Social Security Commissioners (Procedure) Regulations 1999 (S.I. 1999/1495). The amendments are in consequence of Schedule 7 to the Child Support, Pensions and Social Security Act 2000 which makes provision for appeals against decisions made in connection with claims for housing benefit and council tax benefit.

The Social Security Commissioners (Procedure) Regulations 1999 were recently amended by the Social Security Commissioners (Procedure) (Amendment) Regulations 2000 (S.I. 2000/2854). The amendments were in consequence of the transfer under the Tax Credits Act 1999 (c. 10) of functions relating to family credit and disability working allowance (now known as working families' tax credit and disabled person's tax credit) from the Department of Social Security to the Treasury and the Board of Inland Revenue.
