The Northampton Community Healthcare and the Rockingham Forest National Health Service Trusts (Dissolution) Order 2001

Made	21st March 2001
Coming into force	1st April 2001

The Secretary of State for Health, in exercise of the powers conferred on him by section 126(3) of the National Health Service Act 1977(a) and by section 5(1) of, and paragraph 29(1) of Schedule 2 to, the National Health Service and Community Care Act 1990(b) and of all other powers enabling him in that behalf, considering it appropriate in the interests of the health service to make this Order(c), and after completion of the consultation prescribed under paragraph 29(3) of Schedule 2 to the latter Act(d), hereby makes the following Order:

#### **Citation and commencement**

1. This Order may be cited as the Northampton Community Healthcare and the Rockingham Forest National Health Services Trusts (Dissolution) Order 2001 and shall come into force on 1st April 2001.

#### **Dissolution of NHS trusts**

2.—(1) The Northampton Community Healthcare National Health Service Trust established by the Northampton Community Healthcare National Health Service Trust (Establishment) Order 1993(e) is hereby dissolved, and accordingly that Order is hereby revoked.

(2) The Rockingham Forest National Health Service Trust established by the Rockingham Forest National Service Trust (Establishment) Order 1993(f) is hereby dissolved, and accordingly that Order is hereby revoked.
