Whereas, pursuant to section 18(1) of the Agriculture Act 1986⁽¹⁾, the Minister of Agriculture, Fisheries and Food (“the Minister”) has designated areas in Breckland, Clun, North Peak, the Suffolk River Valleys and the Test Valley as environmentally sensitive areas;

Now, therefore, the Minister, in exercise of the powers conferred on her by section 18(1) and (4)(d)⁽²⁾ of the said Act, and of all other powers enabling her in that behalf, with the consent of the Treasury, hereby makes the following Order:

Title and commencement **U.K.**

1. This Order may be cited as the Environmentally Sensitive Areas (Stage II) Designation (Amendment)(No. 2) Order 2001 and shall come into force on 21st December 2001.
