**The Miscellaneous Food Additives (Amendment)
(England) (No. 2) Regulations 2001**

Consequential amendments

9.—(1) Paragraph (2) of regulation 6 (consequential amendments) of the Miscellaneous Food Additives (Amendment) (England) Regulations 2001⁽¹⁾ shall be omitted.
