## Activities carried on in the course of a profession or non-investment business

- **67.**—(1) There is excluded from articles 21, 25(1) and (2) [<sup>F1</sup>, 25A], [<sup>F2</sup>25B, 25C,][<sup>F3</sup>25E,][<sup>F4</sup>39A, 40][<sup>F5</sup>53][<sup>F6</sup>, 53A, 53B, [<sup>F7</sup>53C, 53D and 53DA]] any activity which—
  - (a) is carried on in the course of carrying on any profession or business which does not otherwise consist of [F8the carrying on of regulated activities in the United Kingdom]; and
  - (b) may reasonably be regarded as a necessary part of other services provided in the course of that profession or business.
- (2) But the exclusion in paragraph (1) does not apply if the activity in question is remunerated separately from the other services.
