# The European Communities (Designation) (No. 2) Order 2002

Made - - - 17th April 2002

Laid before Parliament 29th April 2002

Coming into force 20th May 2002

At the Court at Windsor Castle, the 17th day of April 2002

Present,

The Queen's Most Excellent Majesty in Council

Her Majesty, in exercise of the powers conferred on Her by section 2(2) of the European Communities Act 1972(a), and section 29(1) of the Government of Wales Act 1998(b), is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

#### Citation, commencement and interpretation

- 1.—(1) This Order may be cited as the European Communities (Designation) (No. 2) Order 2002 and shall come into force on 20th May 2002.
  - (2) In this Order—

"the Act" means the European Communities Act 1972,

"Minister or government department" means a Minister of the Crown or government department, but does not include a Northern Ireland Minister or Northern Ireland department,

"regulations" means regulations made pursuant to section 2(2) of the Act.

#### **Designation of the National Assembly for Wales**

- **2.**—(1) For the purposes of section 2(2) of the Act, the National Assembly for Wales is designated in relation to the matter specified in the Schedule to this Order.
- (2) Regulations made by the National Assembly for Wales pursuant to this Order shall apply in relation to Wales only.
- (3) Where the National Assembly for Wales is designated by this Order in relation to any matter, for which any Minister or government department is designated by this or any other Order

for the purposes of section 2(2) of the Act, any of them may make regulations and, if regu	ılations
are made by more than one, they may do so jointly.

- (b) the National Assembly for Wales' West Wales and the Valleys Objective 1 Single Programming Document 2000–2006 approved by Commission Decision No. C(2000) 2049 of 24th July 2000,
- (c) the National Assembly for Wales' Rural Development Plan for Wales 2000–2006 approved by Commission Decision No. C(2000)2932 of 11th October 2000,
- (d) the National Assembly for Wales' East Wales Objective 2 and Transitional Programme Single Programming Document approved by Commission Decision No. C(2001)657 of 26th March 2001,
