**The Bournemouth Community and Mental Health National
Health Service Trust Change of Name Order 2002**

Made - - - - - *25th March 2002*

Coming into force *1st April 2002*

The Secretary of State for Health, in exercise of the powers conferred on him by section 126(3) and (4) of the National Health Service Act 1977(a) and section 5(1) of the National Health Service and Community Care Act 1990(b) and of all other powers enabling him in that behalf, having completed the consultation prescribed under section 5(2) of that latter Act(c), hereby makes the following Order:

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Bournemouth Community and Mental Health National Health Service Trust Change of Name Order 2002 and shall come into force on 1st April 2002.

(2) In this Order—

“the Order” means the Bournemouth Community and Mental Health National Health Service Trust (Establishment) Order 1994(d);

“the trust” means the National Health Service trust established by the Order.

Change of name of NHS trust and transitional provisions

2.—(1) The trust shall be called the North West Surrey Mental Health National Health Service Partnership Trust instead of the Bournemouth Community and Mental Health Hospital National Health Service Trust, and accordingly in article 1 of the Order in the definition of “the trust”, and in article 2 of the Order, for “Bournemouth Community and Mental Health National Health Service Trust” there shall be substituted “North West Surrey Mental Health National Health Service Partnership Trust”.

(2) The change of name effected by paragraph (1) shall not—

(a) affect any right or obligation of any person; or

(b) be taken as invalidating any instrument (whether made before, on or after the day on which this Order comes into force) which refers to the trust by its previous name,

and all instruments and other documents which refer to the trust under its previous name shall be construed as referring to it under its new name.

(This note is not part of the Order)

This Order amends the Bournemouth Community and Mental Health National Health Service Trust (Establishment) Order 1994, which established the Bournemouth Community and Mental Health National Health Service Trust, and changes the name of that trust.

Article 2 of the Order changes the name of the trust from the Bournemouth Community and Mental Health National Health Service Trust to the North West Surrey Mental Health National Health Service Partnership Trust, and makes consequential amendments to the Establishment Order and transitional provisions.
