#### SCHEDULE V

#### INCOME FROM CAPITAL

## PART I

#### Capital disregarded for the purpose of calculating income

13.—(1) Subject to sub-paragraph (2), the amount of any trust payment made to a claimant or a claimant's partner  $[^{F1}$  who is]—

- (a) <sup>F2</sup>... a diagnosed person;
- (b) [<sup>F3</sup>a diagnosed person's partner or] was a diagnosed person's partner at the time of the diagnosed person's death;
- (c) <sup>F4</sup>... a parent of a diagnosed person, a person acting in place of the diagnosed person's parents or a person who was so acting at the date of the diagnosed person's death.
- (2) Where [<sup>F5</sup>a trust payment is made to]—
  - (a) [<sup>F6</sup>a person referred to in sub-paragraph (1)(a) or (b), that sub-paragraph] shall apply for the period beginning on the date on which the trust is made and ending on the date on which [<sup>F6</sup>that person] dies;
  - (b) [<sup>F7</sup>a person referred to in sub-paragraph (1)(c), that sub-paragraph] shall apply for the period beginning on the date on which the trust payment is made and ending two years after that date.

(3) Subject to sub-paragraph (4), the amount of any payment by a person to whom a trust payment has been made or of any payment out of the estate of a person to whom a trust payment has been made, which is made to a claimant or a claimant's partner  $[^{F8}$ who is]—

- (a) <sup>F9</sup>... the diagnosed person;
- (b) [<sup>F10</sup>a diagnosed person's partner or] was a diagnosed person's partner at the date of the diagnosed person's death; or
- (c) <sup>FII</sup>... a parent of a diagnosed person, a person acting in place of the diagnosed person's parents or a person who was so acting at the date of the diagnosed person's death.
- (4) Where  $[^{F12}a$  payment referred to in sub-paragraph (3) is made to]—
  - (a) [<sup>F13</sup>a person referred to in sub-paragraph (3)(a) or (b), that sub-paragraph] shall apply for the period beginning on the date on which the payment is made and ending on the date on which [<sup>F13</sup>that person] dies;
  - (b) [<sup>F14</sup>a person referred to in sub-paragraph (3)(c), that sub-paragraph] shall apply for the period beginning on the date on which the payment is made and ending two years after that date.
- (5) In this paragraph, a reference to a person—
  - (a) being the diagnosed person's partner;
  - (b) acting in place of the diagnosed person's parents,

at the date of the diagnosed person's death shall include a person who would have been such a person or a person who would have been so acting, but for the diagnosed person [<sup>F15</sup>residing in a care home or an independent hospital].

(6) In this paragraph—

"diagnosed person" means a person who has been diagnosed as suffering from, or who, after his death, has been diagnosed as having suffered from, variant [<sup>F16</sup>Creutzfeldt]-Jakob disease;

"relevant trust" means a trust established out of funds provided by the Secretary of State in respect of persons who suffered, or who are suffering, from variant [<sup>F16</sup>Creutzfeldt]-Jakob disease for the benefit of persons eligible for payments in accordance with its provisions;

"trust payment" means a payment under a relevant trust.
