**The Avon, Gloucestershire and Wiltshire Health Authority
(Transfer of Trust Property) Order 2002**

Made - - - - - *4th September 2002*

Laid before Parliament *5th September 2002*

Coming into force - - *30th September 2002*

The Secretary of State for Health, in exercise of the powers conferred on him by sections 92(1) and 126(4) of the National Health Service Act 1977(a) and of all other powers enabling him in that behalf, having regard to changes in the area and functions of the Avon, Gloucestershire and Wiltshire Health Authority and having consulted that Health Authority, the Gloucestershire Partnership National Health Service Trust, and the Cotswold and Vale Primary Care Trust in accordance with section 92(3) of that Act, hereby makes the following Order:

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Avon, Gloucestershire and Wiltshire Health Authority (Transfer of Trust Property) Order 2002 and shall come into force on 30th September 2002.

(2) In this Order—

“the old Trust” means the Avon, Gloucestershire and Wiltshire Health Authority(b);

“the new Trust” means the Gloucestershire Partnership National Health Service Trust(c) or the Cotswold and Vale Primary Care Trust(d) as the context requires;

“the trust property” means the property specified in the 2 schedules of trust property more specifically described in paragraphs (1) to (3) of article 2 of this Order.

As regards Wales, the functions of the Secretary of State under the above mentioned powers are transferred to the National Assembly for Wales under article 2(a) of the National Assembly for Wales (Transfer of Functions) Order 1999 S.I.1999/672 as amended by section 66(5) of the 1999 Act; this order therefore only extends to England.

Transfer of trust property

2.—(1) On 30th September 2002 the trust property specified in the schedule of trust property prepared and agreed upon by the old Trust and the Gloucestershire Partnership National Health Service Trust and signed on behalf of both the old Trust on 20th August 2002, and on behalf of the Gloucestershire Partnership National Health Service Trust on 29th August 2002, and any rights and liabilities arising from that property(a), shall be transferred from the old Trust to the Gloucestershire Partnership National Health Service Trust.

(2) On 30th September 2002 the trust property specified in the schedule of trust property prepared and agreed upon by the old Trust and the Cotswold and Vale Primary Care Trust and signed on behalf of the old Trust on 27th August 2002 and on behalf of the Cotswold and Vale Primary Care Trust on 30th August 2002, and any rights and liabilities arising from that property(b), shall be transferred from the old Trust to the Cotswold and Vale Primary Care Trust.

3.—(1) In any trust instrument relating to the trust property, any reference to the name by which the trustees of the trust property are to be known shall be construed as a reference to the relevant new Trust and any reference to the old Trust in the name by which the charitable trust governing the trust property is to be known shall be construed as a reference to the relevant new Trust.

(2) In paragraph (1) of this article references to the relevant new Trust are to be read as references to the new Trust to which the property which is the subject of the trust instrument has been transferred under article 2 of this Order.
