**The Travel Restriction Order (Prescribed Removal Powers)  
Order 2002**

*Made* - - - - - *13th February 2002*  
*Laid before Parliament* - *20th February 2002*  
*Coming into force* - - *1st April 2002*

The Secretary of State, in exercise of the powers conferred on him by section 37(4) of the Criminal Justice and Police Act 2001(a) hereby makes the following Order:

**Citation and commencement**

**1.** This Order may be cited as the Travel Restriction Order (Prescribed Removal Powers) Order 2002 and shall come into force on 1st April 2002.

**Prescribed removal powers**

**2.** Each of the powers set out in the Schedule to this Order is designated as a prescribed removal power for the purposes of section 37 of the Criminal Justice and Police Act 2001.

### EXPLANATORY NOTE

*(This note is not part of the Order)*

Section 33 of the Criminal Justice and Police Act 2001 gives power in some circumstances to a court to make travel restriction orders in relation to offenders convicted of drug trafficking offences.

Section 37 of the Act provides that a travel restriction order made in relation to any person shall not prevent that person being removed from the United Kingdom under a prescribed removal power. This Order designates prescribed removal powers for the purposes of that section.
