**The North Surrey Primary Care
Trust (Establishment) Order 2002**

Made - - - - 25th March 2002
Coming into force - - 1st April 2002

The Secretary of State for Health, in the exercise of the powers conferred on him by sections 16A(1), (2) and (3) and 126(4) of, and paragraph 1 of Schedule 5A to, the National Health Service Act 1977⁽¹⁾ and of all other powers enabling him in that behalf, following compliance with the consultation requirements contained in regulations made under section 16A(5) of the Act⁽²⁾, hereby makes the following Order:

Citation, commencement and interpretation

1.—(1) This Order may be cited as the North Surrey Primary Care Trust (Establishment) Order 2002 and shall come into force on 1st April 2002.

(2) In this Order, unless the context otherwise requires—

“operational date” is to be construed in accordance with paragraph 1(2) of Schedule 5A to the Act;

“the trust” means the North Surrey Primary Care Trust established by article 2 of this Order.

Establishment, operational date and name of the Primary Care Trust

2.—(1) There is hereby established with effect from 1st April 2002 a Primary Care Trust to be called the North Surrey Primary Care Trust.

(2) The operational date of the trust shall be 1st April 2002.

Article 3

AREA OF TRUST

The borough of Runnymede—

the electoral wards of Addlestone, Bourneside, Addlestone North, Chertsey Meads, Chertsey South and Row Town, Chertsey St Ann's, Egham Hythe, Egham Town, Foxhills, Thorpe, Virginia Water.

In the borough of Spelthorne—

the electoral wards of Ashford Common, Ashford East, Ashford North, Ashford Town, Ashford West, Halliford and Sunbury West, Lalcham, Shepperton Green, Shepperton Town, Staines East, Staines Town, Stanwell North, Stanwell South, Sunbury Common, Sunbury East.

In the borough of Elmbridge—

the electoral wards of Hersham North, Hersham South, Oatlands Park, St George's Hill, Walton Ambleside, Walton Central, Walton North, Walton South, Weybridge North, Weybridge South.

EXPLANATORY NOTE

This Order establishes the North Surrey Primary Care Trust (“the trust”), as provided for under section 16A of the National Health Service Act 1977. It specifies the trust’s establishment and operational dates (article 2) and the area for which it is established (article 3 and the Schedule).
