Citation, commencement and interpretation

1.—(1) These Regulations may be cited as the Social Security Amendment (Students and Incomerelated Benefits) (No.2) Regulations 2003 and shall come into force—

- (a) for the purposes of this regulation and regulation 3, on 31st July 2003;
- (b) for the purposes of regulation 2—
 - (i) in the case of a student whose period of study begins on or after 1st August 2003 but before 1st September 2003, on the day the period of study begins;
 - (ii) in any other case, on 1st September 2003.
- (2) In these Regulations—
 - (a) [F1"the Council Tax Benefit Regulations" means the Council Tax Benefit (General) Regulations 1992;]
 - (b) [F1" the Housing Benefit Regulations" means the Housing Benefit (General) Regulations 1987:]
 - (c) "the Income Support Regulations" means the Income Support (General) Regulations 1987 Ms.
 - (d) "the Jobseeker's Allowance Regulations" means the Jobseeker's Allowance Regulations 1996 M6.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the Council Tax Benefit (General) Regulations 1992 (S.I. 1992/1814), the Housing Benefit (General) Regulations 1987 (S.I. 1987/1971), the Income Support (General) Regulations 1987 (S.I. 1987/1967) and the Jobseeker's Allowance Regulations 1996 (S.I. 1996/207) in so far as those Regulations apply to students. In particular these Regulations increase the amount of grant and loan income to be disregarded in respect of books and equipment (regulation 2).

These Regulations also revoke regulation 2(2) of the Social Security Amendment (Students and Income-related Benefits) Regulations 2003 (S.I. 2003/1701) which contains an inaccuracy (regulation 3) and are consequently issued free of charge.

These Regulations do not impose any charge on business.
