**Education (Revocation of Spent Provisions) (England)
Regulations 2003**

In exercise of the powers conferred upon the Secretary of State by sections 29(5) and 408 of the Education Act 1996(a), section 144 of the School Standards and Framework Act 1998(b) and section 214 of the Education Act 2002(c), the Secretary of State for Education and Skills hereby makes the following Regulations:

Citation and commencement

1.—(1) These Regulations may be cited as the Education (Revocation of Spent Provisions) (England) Regulations 2003.

(2) These Regulations come into force on 30th November 2003.

Revocations

2.—(1) The Regulations listed in Part 1 of the Schedule (which have effect only in relation to England) are hereby revoked to the extent specified here.

(2) The Regulations listed in Part 2 of the Schedule are hereby revoked in relation to England to the extent specified here.
