

SCHEDULE 2

PROHIBITED DUAL-USE GOODS, SOFTWARE AND TECHNOLOGY AIRCRAFT AND RELATED TECHNOLOGY

PL9009

The export or “transfer” of the following “goods” or “technology” is prohibited to any destination in Iran ^{F1}...:

- (a) “Aircraft” [^{F2}, “lighter-than-air vehicles” and steerable parachutes,] and related equipment and components, as follows, other than those [^{F3}specified in] Part I of Schedule 1 to this Order or Annex I to “the Regulation”:
 - (1) “Aircraft” [^{F4}, “lighter-than-air vehicles” and steerable parachutes];
 - (2) Equipment and components designed for “aircraft” [^{F5}and “lighter-than-air-vehicles,”] as follows:
 - (a) Airframe structures and components;
 - (b) Aero-engines and specially designed components therefor;
 - (c) Avionics and navigation equipment and specially designed components therefor;
 - (d) Landing gear and specially designed components therefor, and aircraft tyres;
 - (e) [^{F6}Propellers and rotors;]
 - (f) [^{F6}Transmissions and gearboxes, and specially designed components therefor;]
 - (g) [^{F6}Unmanned aerial vehicle (UAV) recovery systems;]

- (c) “Technology” according to the General Technology Note ^{F1}... for the “development”, “production” or “use” of “goods” [^{F8}specified] in PL9009.a.^{F9}...

Note: PL9009.c. does not control technical data, drawings or documentation for maintenance activities directly associated with calibration, removal or replacement of damaged or unserviceable “goods” that are necessary for the continuing airworthiness and safe operation of civil “aircraft”.
