The Northern Birmingham Mental Health National Health Service Trust (Transfer of Trust Property) Order 2003

The Secretary of State for Health, in exercise of the powers conferred on him by sections 92(1) and 126(4) of the National Health Service Act 1977(1) and of all other powers enabling him in that behalf, having regard to changes or proposed changes in the arrangements for the administration of Northern Birmingham Mental Health National Health Service Trust and having consulted that Trust and the Birmingham and Solihull Mental Health National Health Service Trust in accordance with section 92(3) of that Act, hereby makes the following Order:

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Northern Birmingham Mental Health National Health Service Trust (Transfer of Trust Property) Order 2003 and shall come into force on 1st April 2003.

(2) In this Order—

“the old Trust” means the Northern Birmingham Mental Health National Health Service Trust(2);

“the new Trust” means the Birmingham and Solihull Mental Health National Health Service Trust(3);

“the trust property” means the property specified in the schedule of trust property prepared and agreed by the old Trust and the new Trust and signed on behalf of the old Trust on 5th February 2003 and on behalf of the new Trust on 6th February 2003.

As regards Wales, the functions of the Secretary of State under the above mentioned powers are transferred to the National Assembly for Wales under article 2(a) of the National Assembly for Wales (Transfer of Functions) Order 1999 S.I.1999/672 as amended by section 66(5) of the 1999 Act; this order therefore only extends to England.

Transfer of trust property

2.—(1) On 1st April 2003 the trust property, and any rights and liabilities arising from that property⁽⁴⁾, shall be transferred from the old Trust to the new Trust.

(2) In any trust instrument relating to the trust property, any reference to the name by which the trustees of the trust property are to be known shall be construed as a reference to the new Trust and any reference to the old Trust in the name by which the charitable trust governing the trust property is to be known shall be construed as a reference to the new Trust.
