The Medicines (Pharmacy and General Sale—Exemption) Amendment (No. 2) Order 2004

Made - - - - 22nd April 2004
Laid before Parliament 27th April 2004
Coming into force - - 18th May 2004

As regards England, Scotland and Wales, the Secretary of State concerned with health in England, and, as regards Northern Ireland, the Department of Health, Social Services and Public Safety, acting jointly, in exercise of the powers conferred upon them by sections 57(1) and (2) and 129(4) of the Medicines Act 1968(a) or, as the case may be, those conferred by the said provisions and now vested in them(b), and of all other powers enabling them in that behalf, after consulting such organisations as appear to them to be representative of interests likely to be substantially affected by this Order, pursuant to section 129(6) of that Act, and after taking into account the advice of the Committee on Safety of Medicines pursuant to section 129(7) of that Act, hereby make the following Order:—

Citation, commencement and interpretation

- 1.—(1) This Order may be cited as the Medicines (Pharmacy and General Sale—Exemption) Amendment (No. 2) Order 2004 and shall come into force on 18th May 2004.
- (2) In this Order, "the principal Order" means the Medicines (Pharmacy and General Sale—Exemption) Order 1980(c).

Amendment of article 1 of the principal Order

2. In article 1(2) of the principal Order (interpretation), in the appropriate alphabetical place, insert the following definitions—

"registered dietitian" means a person who is registered in Part 4 of the register maintained by the Health Professions Council under article 5 of the Health Professions Order 2001(d);";

""registered occupational therapist" means a person who is registered in Part 6 of the register maintained by the Health Professions Council under article 5 of the Health Professions Order 2001;";

""registered orthotist and prosthetist" means a person who is registered in Part 10 of the register maintained by the Health Professions Council under article 5 of the Health Professions Order 2001;"; and

"registered speech and language therapist" means a person who is registered in Part 12 of the register maintained by the Health Professions Council under article 5 of the Health Professions Order 2001;".

Amendment of Schedule 3 to the principal Order

3. In Schedule 3 to the principal Order(a) (classes of individual by whom supplies may be made), at the end of the list in Part III add—

"Registered dietitians.";

"Registered occupational therapists.";

"Registered orthotists and prosthetists."; and

"Registered speech and language therapists."

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Medicines (Pharmacy and General Sale—Exemption) Order 1980 ("the principal Order") which provides for exemptions to sections 52 and 53 of the Medicines Act 1968 (restrictions on the sale or supply of medicinal products).

Article 3 amends Part III of Schedule 3 to the principal Order by adding registered dietitians, occupational therapists, orthotists and prosthetists and language and speech therapists to the list of classes of individuals who can supply medicinal products under a Patient Group Direction.
