The Road Traffic (Permitted Parking Area and Special Parking Area) (County of Warwickshire) (District of Stratford on Avon) Order 2004

Citation and commencement

1. This Order may be cited as the Road Traffic (Permitted Parking Area and Special Parking Area) (County of Warwickshire) (District of Stratford on Avon) Order 2004 and shall come into force on 4th October 2004.

Interpretation

2. In this Order—

"the 1984 Act" means the Road Traffic Regulation Act 1984(1);

"the 1991 Act" means the Road Traffic Act 1991; and

"the parking area" means the area designated as a permitted parking area and as a special parking area by article 4 of this Order.

Application

- 3. This Order applies to the whole of the district of Stratford on Avon except—
 - (a) the entire length of the M40, including its on and off slip roads, within the district;
 - (b) the entire length of the M42, including its on and off slip roads, within the district;
 - (c) the entire length of the A46 within the district;
 - (d) the A429 from the northern boundary of the district to the point immediately before the junction with the driveway to Manor House, Halford;
 - (e) the A429 from the southern boundary of the district to a line projected across the road from the southern boundary of the grounds of the Halford Bridge Inn, Halford;
 - (f) the A435 Alcester Bypass, from its roundabout junction with the B4089 and B4090 (but not including the circulatory carriageway at that junction) to its roundabout junction with the A46 and including the circulatory carriageway at that junction;
 - (g) the A439 from its junction with the A46 to the point immediately before its junction with St Gregory's Road, Stratford-upon-Avon;
 - (h) the A3400 from the point immediately after its junction with the driveway to King Stone Farm, Long Compton, to the southern boundary of the district; and

(i) the A4390 from its roundabout junction with the A3400 to its roundabout junction with Evesham Place, Stratford-upon-Avon (but not including the circulatory carriageway at either such junction).

Designation of permitted parking area and special parking area

- 4. The Secretary of State hereby designates the area to which this Order applies as—
 - (a) a permitted parking area; and
 - (b) a special parking area.

Modification and application of Part II of the 1991 Act

5. Sections 66, 69 to 74, 78, 79 and 82 of, and Schedule 6 to, the 1991 Act, shall apply in relation to the parking area and as so applied shall have effect subject to the modifications specified in Schedule 1 to this Order.

Modification of other provisions

6. The 1984 Act shall be modified in relation to the parking area as specified in Schedule 2 to this Order.
